#### *Instructions*

Completion of the scholarship application will be a joint effort between the full-time faculty member and their dependent child. When filling out all forms, please type, print or write legibly. Below are specific instructions for each part of the application. If you have questions, please e-mail them to Maggie at [schorr7@comcast.net](mailto:schorr7@comcast.net).

**Scholarship Application Form:** Self-explanatory.

#### *Full-time Faculty Member Applicant*

**Employment Verification Form:** Fill out and sign the top portion of the form, then give the form to the principal, vice principal, or business manager of the school where you are currently employed. It is your responsibility to ensure that the form is filled out and signed by a school official who must return the form to you for inclusion with your completed application.

**Full-time Faculty Member Recommendation Letter:** Fill out and sign the top portion of the Full-time Faculty Member Recommendation Form and give it to the principal, vice-principal, supervisor, or pastor whom you have requested to write you a letter of support. The person writing the letter should place the recommendation in a sealed envelop, sign across the sealed flap, then return the envelope containing the letter and the Recommendation Form to you for inclusion with your application.

**Financial Need:** All high school scholarship applicants must complete a need analysis form provided by FACTS. We are pleased to offer you a convenient, online method to complete the need analysis form through FACTS for Colleen and Erin Marlatt Scholarship Fund, INC. Here is the link <https://online.factsmgt.com/signin/4KZT4>. The due date for the FACTS information is the same as for the completed Colleen & Erin Marlatt Scholarship application, March 1, 2020.

**Signature Form:** Please read carefully, sign and date the signature form. The student applicant must also read, sign, and date the form.

## *Student Applicant*

**Student Eligibility:** The student must be ENTERING a Catholic high school in the Archdiocese of Baltimore as a FRESHMAN in the fall of 2020. Current high school students are not eligible to apply.

**Student Recommendation Form:** Fill out and sign two forms and give them to those whom you have asked to write letters of recommendation for you. One letter MUST be written by a teacher who has taught you within the last two academic years. The other must be written by someone other than a teacher. Examples include coaches, employers, priests or other ministers, or Scout leaders. Although it is preferable that the second letter be from someone outside of your school community, it is acceptable that someone from your school write your second letter as long as they have interacted with you in activities outside of the classroom.

**Essay:** *High school applicants:* Compose an essay of not more than 250 words entitled “Who has influenced your life the most, and how have they shaped your future?”

Although you are encouraged to have someone proofread your essay, you are expected to write the essay by yourself.

**Signature Form:** Please read carefully, sign and date the signature form. The full-time faculty member applicant must also read, sign, and date the form.

## *Scholarship Continuation Criteria*

High School: Recipient must maintain a grade point average equal to or equivalent to a 3.0 or a scale of 0.0 - 4.0.

The full-time faculty member must remain in the employment of a Catholic school in the Archdiocese of Baltimore, on a fulltime basis.

The full-time faculty member must submit the required financial verification documentation and remain financially eligible to apply for a scholarship.

UMCP: Recipient must maintain a 3.00 cumulative grade point average and not a semester average below 2.50 grade point average.

The full-time faculty member must remain in the employment of a Catholic school in the Archdiocese of Baltimore, on a fulltime basis.

The full-time faculty member must submit the required financial verification documentation and remain financially eligible to apply for a scholarship.
